NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN.

ELIGIBILITY

Participation in a PacBio® Social Media Giveaway is open to individual entrants (excluding vendors) meeting these eligibility requirements. Entrants must have attained at least the age of majority in their jurisdiction of residence (entrants must, in any event, be at least 18 years of age). Employees, officers, directors, agents, representatives and independent contractors of PacBio and its subsidiaries or affiliated companies, together with their immediate family members and members of the same households (whether related or not) are not eligible to participate. Entries will be tracked by a third-party tool. Participants who successfully follow all instructions will automatically be entered into a prize giveaway draw. Winners will be selected in a random drawing from among all eligible entries received by PacBio by the end date of the contest. The selected winners will be attempted to be notified via direct messaging on Twitter within approximately five (5) business days after selection. If a selected winner has not responded to direct messaging communications an alternative winner may be selected in a random drawing from all non-winning entries, at PacBio's discretion. The odds of winning depend on the number of eligible entries received.
